In order to promote new perspectives and innovative activities, which can contribute to the development of commercial, industrial and shipbuilding entrepreneurship of Piraeus, but also to our national economy, P.C.C.I. is in a constant effort to achieve an open channel of communication with European counterparts and to develop a common exchange of views for the creation of synergies.

In this effort to expand bilateral relations with "Euro-Chambers of cities-ports", P.C.C.I. has signed Memoranda of Understanding with Hamburg Chamber of Commerce and Industry and Barcelona Chamber.

# Cooperation Agreement

## between the Genoa Chamber of Commerce and the Piraeus Chamber of Commerce & Industry

The **Genoa Chamber of Commerce** (Italy) on behalf of its President, ....., from one side, and the **Piraeus Chamber of Commerce & Industry** (Greece) on behalf of its President, Mr. Vassilis Korkidis, from the other side, hereinafter called Parties,

based on the interest in creating favorable conditions for the development of economic relations between enterprises of Genoa and Piraeus,  
recognizing the necessity to maintain and develop economic, cultural and other ties

agreed as follows:

### Article 1

The Parties support the development of direct contacts between enterprises, organizations, companies, entrepreneurs and their associations of Genoa and Piraeus.

The Parties apply all the necessary measures for further bilateral cooperation development and wide range participants' involvement.

### Article 2

Within their competence, the Parties exchange broad economic and legal information about national economy development, Parties' investment activity, as well as relevant standard acts, which regulate international economic activity, and other informative materials.

### Article 3

The Parties regularly consult on matters of common interest and hold joint meetings to improve trade and economic cooperation between Genoa and Piraeus

### Article 4

Parties organize seminars, exhibitions, fairs, workshops, conferences and other events in order to familiarize business communities with the economy and export capabilities of Genoa and Piraeus

### Article 5

The Parties support small and medium enterprises' development, search partners for cooperation and provide other services for the enterprises and organizations of both Parties.

### Article 6

Under this Agreement, the Parties coordinate their activities within regular meetings and working contacts.

### Article 7

Financial arrangements for joint events are carried out on a commercial basis and regulated by the Parties in separate agreements.

### Article 8

In case of disagreement and discussions regarding the implementation of the Agreement provisions, the Parties regulate them by means of negotiations.

### Article 9

This Agreement may be amended or supplemented by Parties mutual agreement.

Amendments and supplements are issued as a separate protocol to the Agreement and enter into force on the date of signing this protocol by authorized representatives of both Parties.

This Agreement enters into force upon signature by both Parties for an indefinite period and may be terminated by either Party by written notice. In this case, the Agreement will lose its power within 30 days after receiving notice of its termination.
